Provided funds to implementing partner Handicap International Federation which surveyed and released a total of 181,175.37 square meters of land, in 500 villages in the Casamance region and conducted mine risk education in 15 schools and 20 border communities to help prevent harm to civilians caused by explosive remnants of war.

Haiti - \$566,359

As a response to the 2010 earthquake, funds were provided to implementing partner Handicap International Federation which contributed to the provision of physiotherapy and occupational therapy to 10,000 injured people as well as the fitting of 900 individuals with prostheses and orthoses. Psychosocial assistance and case management were also provided to 25,000 physically and socially vulnerable people with injuries. Handicap International Federation began the construction of 1,000 transitional shelters, which are accessible to persons with disabilities. Furthermore, Handicap International Federation has managed seven Disability and Vulnerability Focal Points (DVFP). DVFPs identify the basic and specific humanitarian needs of vulnerable people, provide services, and refer beneficiaries when appropriate.

US Campaign to Ban Landmines - \$202,683

As the coordinating organization for the US Campaign to Ban Landmines, Handicap International and the rest of the USCBL coalition have worked to ban further U.S. use, production, and export of anti-personnel landmines and cluster bombs: to encourage the U.S. to join the 1997 Mine Ban Treaty and the 2008 Convention on Cluster Munitions and to increase U.S. government support for demining.

Generally the 990 is reviewed at a Board meeting, but when no Board meeting has been scheduled the 990 is sent out electronically with a request that Board members review the document and indicate any questions.

All staff and board members are made aware of the conflict of interest policy and their responsibility to report any potential conflicts of interest. Staff review and sign the policies and personnel manual at the time of their hire, which includes the conflict of interest policy. Additionally at a scheduled meeting of the Board of Directors all directors are asked to review HI's definition of conflict from the organization's bylaws and to then affirm that they have done so and sign a
